Veterinary Certificate of Soundness

As per Clause (1) under "INSPECTION" of the ANKC Rules for the Conduct of Endurance Trials (Effective 1 January 2019); A veterinary certificate, issued within fourteen (14) days immediately prior to the date of the test, must be submitted, for each dog on the day. It shall cover such things as the general fitness, temperature, standing heart rate, condition of the pads and muscle tone of the dog. For bitches the certificate is to state also that the bitch is not in whelp.

The holder of this form is intending to compete in an Endurance Test consisting of a 20km run/ride at an average of 10km/h. It is completed in three (3) sections: 1 x 8km with a 15 minute break and a Vet Check, 1 x 6km with a 20 minute break and a Vet Check, concluded with 1 x 6km with a 15 minute break followed by a short obedience test.

The following information is required by the Owner within 14 days of the Test date and is to be handed to the Trial Secretary prior to the pre-test Vet Check on the day of the Test.
