PRESENTATION

Presentation will be after completion of all elements. Pass cards will not be available prior to presentation.

CHECK IN TIMES

For dogs entered all numbers must be personally collected between 7:00 am – 7:30 am from the Check In desk.
All bitches will need to be vetted and competitor numbers marked.
Competitor numbers are to be collected at check-in.

TOILETS

Toilets are located to the right of the parking area and beside the Trial Area (Upper Rings) (not to be used during Nov/Adv Ext, Adv Con).
