LOCATION:

IMPORTANT TIMES

Gates will not open to the grounds until 2.30pm

There will be TWO check in times:

Novice, Advanced and Masters

Check-in: 3pm – 3:15 pm

Judging: 3.30pm

Novice and Advanced will run concurrently. Masters will begin as soon as Novice has finished.

There will be presentations for Novice, Advanced and Masters as soon as all three classes have finished.

Competitors who are not entered in Excellent may leave as soon as you have run (if you don't have a volunteer job) or after presentations.

Excellent

Check-in: 4.30pm

Judging: When the presentations for session 1 finish (not before 4.30pm).

PARKING

1. Masters competitors please park on the far (southern) side of the toilet block as shown on the map below. Do not go past the toilet block until called while Masters is being judged or you will view the search area and risk disqualification.
2. A search will be conducted in the men's change area (toilet block). As such there will be a NO PARKING zone near the men's toilets, marked by cones.
3. The parking area available is quite small. Please crate dogs in cars if possible.
4. Reactive dogs: We do not have a set parking area for reactive dogs but ask that you park considerately if you have a reactive dog. Barking and lunging dogs will be asked to move.

AWARDS and PRESENTATIONS

Rosette and prize for first, second and third (Qualifying Scores only). Qualifying Ribbons available.

Presentations for Novice, Advanced and Masters will be held at the conclusion of these events.

Presentations for Excellent will be after completion of all classes.

Qualifying certificates will not be available prior to the respective presentations.

CATERING

There is NO catering available on-site and the closest (open) shops are in Caboolture. Please bring food and drinks as needed.

DOGGY TOILETING

At all times a competitor shall be responsible for cleaning up after their dog/s.

Please be respectful of other dogs when you are toileting your dog.

HUMAN TOILETING

Human toilets are located next to the parking area. The men's toilets will not be available for competitors to use and are **strictly out of bounds**. Men, please use the disabled toilet on the same side as the female toilets.

OTHER STUFF

If you wish to withdraw from a class, please notify the Assembly Steward.

If any details in the catalogue are incorrect it is your responsibility to advise the Trial Secretary. Qualifying certificates will not be reprinted.

Rudeness and aggressive behaviour towards any Trial Officials or Helpers will not be tolerated and will result in a disqualification.

PLEASE DO NOT WALK OR DRIVE PAST CONES UNTIL CALLED BY A COMPETITION MARSHALL OR YOU RISK DISQUALIFICATION.

Dogs must NOT be tethered. For the safety of all dogs, human competitors and other ground users who may come into our area, dogs must be crated or securely in cars.

As per ANKC rules, bitches in season (of the canine variety!) are not allowed on the grounds. All entire bitches must be presented for vetting at check-in. A list of entire bitches will be checked off.

Volunteer Job Descriptions

Car park marshals: round up competitors in their running order and send to the warm up boxes when vacant.

Warm up boxes: check competitors are arriving in order, reset containers, send to the next station once vacant

Judge's steward:

- Make sure the judge is ready and that the judge has cleared the area
- Call next competitor into the search area from the station.
- Mark off the competitor as they enter search area and make sure it's the right competitor.
- Check for dangly bits (on collars, no need to get too personal!)

Timer: take search time and communicate to judge
