PARKING

AWARDS

Sashes and prize for first, second and third (Qualifying Scores only). Qualifying Ribbons available. There will be a prize for the highest achieving Golden Retriever in Trial.

PRESENTATION

Presentation will be after completion of all elements. Pass cards will not be available prior to presentation.

CHECK IN TIMES

For dogs entered all numbers must be personally collected between 7:00 am – 7:30 am from the Check In desk.
All entire bitches will need to be vetted and competitor numbers marked.
Competitor numbers have been emailed and are to be printed or written out and brought with Competitors.

TOILETS

Toilets are located to the right of the parking area and beside the Trial Area (Upper Rings) (not to be used during Exterior/Container).

COMPETITORS
