Parking

Behind Dogs ACT. Please enter the EPIC grounds via Gate 4 (Ampol Service Station) from the Federal Highway. Hopefully EPIC will have the gate open (if not, come in through the Caravan Park entrance - Gate 9 from Old Wells Station Road. Please leave the area closest to Dogs ACT for officials to park.

Catering

Plan to bring your own. Food and drinks are available at the nearby Ampol Service Station or McDonalds on your way to the venue but NOT when judging is occurring due to line of sight issues.

Managing your dog

- Dogs and handlers must stay in the car park unless preparing to search, searching or returning from their search to avoid contaminating the search area, interrupting a search underway, or from viewing a search area. Dogs should either be in the car or a crate near the car when not being toileted or getting ready for a search.
- Dogs must be on lead at all times at the Trial. There are no off-lead exercise areas. Please clean up after your dog.

- Please respect other handlers and their dogs as they move around the venue and keep a reasonable distance between you. If your dog is reactive, please think about selecting a spot further away from the main parking area.
- The handler is responsible for having their dog ready when it is due to search.

Additional Competitor Information

- Catalogue numbers for the trial will be available at check-in.
- Please notify the Trial Manager of any errors in your catalogue entry. This information has been derived from Show Manager and will be used to print any qualification cards.
- Do NOT bring target odour to the trial. Anyone found in possession of target odour at the trial will be disqualified.
- No scent work training on the grounds during the trial penalty disqualification.
- Handlers should not visit the trial location prior to the trial date.
- Spectators will NOT be permitted due to space considerations.
- Bitches in oestrum may NOT be trialled. Vetting arrangements will be provided as required.
- Dogs ACT Regulation Part 20 provides that "A contracted Scent Work Judge may compete in Scent Work competition at the same trial for which they are contracted providing they are not competing in the class/s they have been contracted to judge."
- Ms Temby has entered Advanced Containers as per the catalogue.
- We want to be able to optimise the trial searches so that judges can also compete.
