**Venue:** Oxley State School, Bannerman St Oxley

### IMPORTANT TIMES

**Competitor Carpark Access:** From 5:15PM (NO ACCESS PRIOR TO THIS TIME DUE TO AFTER SCHOOL CARE)

**Check In:** Group 1: 5:15PM – 5:45PM, GROUP 2: From 6:30PM/ad hoc

**Walk Throughs:** 5:45PM (Video posted)

**Judging:** Group 1: 6:00PM, GROUP 2: No earlier than 7:00PM

### PARKING

Please enter via the Bannerman St Entry. The carpark is immediately on the right as you enter, however you need to drive about 50m into the school to the carpark entry. Please see map and photos below.





Car parking will be tight however everyone can fit if everyone parks thoughtfully. The photo below demonstrates how this area can be used for additional spaces.

There is NO separate reactive parking. We ask that competitors please be considerate of their fellow competitors and give them as much space as possible (as you usually do, thank you!). For those competitors with reactive dogs, we recommend you bring some screening, window covers or a gazebo with sides to place over your vehicle in case your dog needs additional line-of-sight screening.



## **CHECK-IN PROCEDURE**

1. GROUP 1 - Please check-in at carpark between 5:15PM and 5:45PM for BOTH STREAMS trials.
2. If you have an entire bitch you will need to have her vetted. Please contact a trial official to accompany you to your vehicle to complete vetting.
3. Competitor numbers have been emailed out for both trials. Please print or write them out prior to arrival.
4. VIDEO walk throughs of BOTH search areas will be posted at 5.45PM in the FB Ultimate Trial Group.

## **DOGGY TOILETING**

At all times you shall be responsible for cleaning up after your dog/s. There is no grass available in the carpark area, so you will need to leave the grounds to toilet your dog along the footpath in Bannerman St and you must collect and take all poop with you. Excessive barking will not be tolerated, please be very mindful of nearby residents.



## **HUMAN TOILETING**

To avoid seeing search areas, it is important that all competitors follow the cones and stay within the barricade tape from the parking area to the toilets. Do NOT take any other route to the toilets or into any marked “no-go zone”, or you risk disqualification.



## **CATERING**

There will be no catering at this trial. There are nearby shops located further along Oxley Road (1118 Oxley Rd), McDonalds Oxley (2098 Ipswich Rd, Oxley), Subway (Shop 9/2118 Ipswich Rd, Oxley) or at Woolworths at the Oxley Station Shopping Centre (133 Oxley Station Rd, Oxley).

## **QUALIFYING CERTIFICATES AND AWARDS**

Qualifying certificates will be issued electronically after the trial.

Rosettes are available for qualifying competitors and ribbons for 1st, 2nd and 3rd (qualifying scores only).

## **RUNNING OF THE TRIAL**

- The Trial will commence at 6:00PM, except for the highlighted dogs who will run PRIOR (Judges, Shadow Judges, Human Distractors and DiW alternate handlers).
- Competitors are allocated by random draw to "Ultimate A" or "Ultimate B" streams under either Judge (excepting Judges).
- Both "Ultimate A" and "Ultimate B" searches will run SIMULTANEOUSLY.
- Because we have only a small number of competitors, and to avoid dogs being kept waiting too long, competitors will be expected to largely self-manage.
- Warm up boxes will be available next to the carpark, and shared between both searches.
- There is no rush but please make sure you are on-deck for your search within a few minutes of the previous competitor leaving.
- You may leave as soon as you have run, However, if you are leaving early, please arrange for someone to collect your place ribbon/prize if required.
- IF YOU ARRIVE BEFORE 5:15PM, please wait in your car. The school has after-hours care and we need to be respectful of the children on site.
- Dogs in White / Demo Dogs ONLY are to be out of cars in the trial precinct prior to 5:45PM.

### **ULTIMATE A Search:**

- There will be a single station just beyond line-of-sight between the carpark and the search, so please make your way to the edge of the carpark when the previous competitor has been called into the search after you have warmed up. Move up to the station as soon as it has been vacated by the previous competitor.
- The walk in / walk out route cone colour will be confirmed in the video briefing.

### **ULTIMATE B Search:**

- There will be a single line-of-sight station between the carpark and the search, so please make your way to the station when the previous competitor has been called into the search (via the warm up boxes if you wish).
- The walk in / walk out route cone colour will be confirmed in the video briefing.
