Handlers are requested to remain within close proximity of "the Shed" so as to be available to track at any time. Your co-operation would be appreciated

#### General Information:

All attendees do not have to wear masks. This is an individual choice.

We do ask for common sense around distances when setting up and during presentation.

#### 1. Advice to attendees:

- People must not attend if they have any of the following symptoms-fever, sore throat, dry cough, runny nose or shortness of breath. This applies to those with even the mildest symptoms. **Should not attend**
- Any person that has received a positive COVID test in the last 5 days. Should not attend

#### 2. Check in

• All bitches will be vetted by their owner/handler under supervision

### 3. Attendees Catering

- No catering will be provided. Attendees should bring their own food and cold drinks if required.
- The club will have hot water and supply, tea, coffee, sugar and milk.

#### 4. Toilets

 We ask that there is no loitering in the toilets. Toilets will be cleaned by the club.


## **Safety Procedures for Tracking Trials**

- Tracking Trials are held over undulating and hazardous terrain (including near water),
  it is suggested that sturdy footwear and clothing be worn to reduce the possibility of
  injury. As with all outdoor activities it is suggested competitors and spectators have appropriate protective clothing for the weather and take due care when moving around
  the trial site and training area.
- 2. The environment, animals and wildlife can be inhospitable. Be alert and avoid problems where possible.
- 3. If you have children in your custody it is your responsibility to ensure the safety and welfare of the children at all times.
- 4. We are privileged to be invited on to properties to run our trials and must respect the property owners personal property and should therefore:
  - Remove all rubbish from the property
  - Do not enter any dwelling on the property
  - Do not touch any farm equipment on the property
  - Ensure that dogs are on lead and kept under control at all times especially around livestock
  - All gates must be left as they are found when entering a paddock
- 5. The first aid box will be in "the Shed" at Haddon Gun Range (base). If emergency first aid is required contact base and the appropriate steps will be taken.
