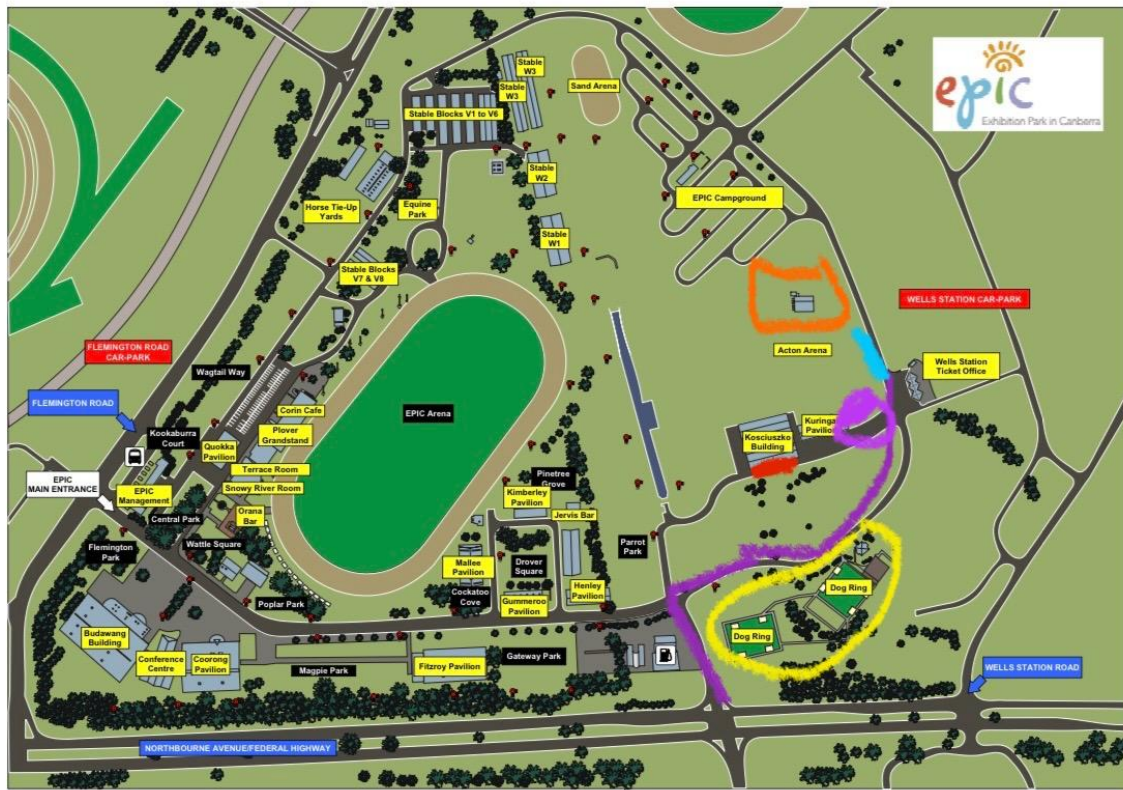

Trial details:

- Online entries only - \$17 per entry available at <https://showmanager.com.au>
- Entries capped at 30 per judge.
- Running order will be provided at the event and on Canberra Canine Nosework Facebook site
- Advanced will commence after a brief reset after Novice has run - Presentations at completion of trial, Electronic Qualification cards.
- Parking on the road next to the clubhouse or in the gravel carpark at clubhouse.
- Trial timings: Check-in for both classes 5-5:30pm. Competitors' briefing 5:45pm. Trial commences at 6pm.
- Ribbons for 1st place, 2nd place, and 3rd place and titles
- Trial Manager: Debbie Smith - 0413118077 (text preferred method of communication)
- A separate entry form must be submitted for each entry (Scent Work Rules s8.1.2)
- Competitors must only enter the Classes they are eligible to enter (Scent Work Rules: s6.1 and s6.2)
- No upgrades will be allowed after the trial closing date
- At any trial a dog may be entered in only one (1) class within an Element
- Only one dog/handler per Class. An owner entering two dogs in the same Class must advise the name of a second handler (who is current and financial with a member body). Dogs from the same family will run concurrently
- Competitors should not visit the trial location 1 week prior to the trial date
- ACT GSD Club reserves the right to make any changes that will ensure the smooth conduct of the trial, to substitute or appoint additional judges and to accept or reject entries.
- Spectators are not permitted in Novice classes.
- No target odour to be brought to the grounds. No scent work training on the grounds during the trial or two weeks prior to the trial
- Bitches in oestrus may NOT be trialled
- Self Refund available till trial closes, no refunds after trial has closed.

ACT Government COVID rules to apply.

Please do not attend if you feel unwell or have been in contact with anyone suspected of having COVID -19.



Entry should be via gate 4 Stirling Ave, EPIC highlighted here in purple follow the purple till you get to the big shed used for farmers market (and all competitors must park where Ive highlight in red so either in the shed or just behind it and toileting just between there till you get to the road where dogs act is opposite. If you have any issues with gate 4 they always leave gate 9 (campers entrance) open - that's entrance with the big double gates down on wells station road - prob the 3rd or 4th gate down off federal hwy.

Check in will be there at the shed in the red area. I don't want you parking in the blue along the road till after the trial has finished running as it will disturb the dogs trialling or going back to their cars with everyone parking at the road.

Please do not check friends in unless they have actually arrived so we don't wait for someone on a catalogue to do a run if theyre not there. Please text 0401362265 Victoria if unable to attend so we can withdraw you from the catalogue

Any triallers arriving after check in has closed will not be allowed to run.

Presentations - at the end of the day - please organise for someone to grab your qualie if you don't intend to stay for the afternoon session.

Toilets prob best at maccas before you come through as dogs act may be locked, toilets available at clubhouse hopefully just before trial will start.

Weather on average min of 10c and max 20-25c around 22 march in canberra.
